
INFORMATION ABOUT PERSONAL DATA PROCESSING for business partners and clients
according to the General Data Protection Regulation (GDPR)

Dear business partners and clients,

JEES company appreciates your trust. Our goal is to keep your data protected, including your personal data, when processing it. JEES company, Nádražní 745, 250 01 Brandýs nad Labem, Company Identification Number: 48025569, Tax Identification Number: CZ48025569, processes all personal data in full compliance with the legal and legislative regulations regulating the protection of personal data pursuant to EU Regulation 2016/679 and Act No. 101/2000 Coll., on the Protection of Personal Data.

The purpose of this statement is to inform you about the processing of personal data that occurs when you visit the company's website (www.powerair.eu), as well as about some other cases of personal data processing, when during the activities of JEES company, personal data of other people (for example, customers, competitors, etc.) are processed.

1. Contact details of Data Controller

2. Purposes of data processing

The Data Controller will process the personal data of the data subject to fulfil the contractual relationship in the field of trade, supply and production of mouldings and rolled metal sheets, including related activities, supported by the following legal bases of processing:

- Data subject consent: for marketing purposes when sending new product offerings and other advertising messages
- Execution or conclusion of the contract: for the supply of goods and services
- Legal duty (Act No. 89/2012 Coll., The Civil Code, Act No. 499/2004 Coll., on Archives and a Filing Service, Act No. 455/1991 Coll., Trades Licensing Act, Act No. 563/1991 Coll., on Accounting, Act No. 235/2004 Coll., on Value Added Tax)

3. Processing of personal data for sending newsletters

Personal data of the data subject will begin being processed by JEES company only after the client confirms his/her consent to the sending of newsletters and other advertising messages.

The provided personal data are processed until the revocation of the granted consent. JEES company will provide the processing of the personal data.

The consent to this processing of personal data is entirely voluntary and can be revoked at any time, both by sending notice of withdrawal of consent in writing to the address of the company's registered office (see above), and also by e-mail to tomas.hruby@jees.cz. The JEES company is not allowed to send you any marketing e-mails without your consent.

4. Processing of personal data in connection with the production and supply of goods and services

In the event of the concluded contractual relationship implementation concerning the production and delivery of products or services, JEES company shall process the customer's personal data, including the name of the company, name, surname, address, Company identification number, tax registration number, e-mail address, telephone number, bank account number and delivery address, in case the goods are delivered to the address specified in the order.

JEES company shall carry out the processing of the above-mentioned personal data for purposes of concluding the purchase contract, supplying of the ordered goods, and last but not least, for the purposes of protecting its rights and the legally protected interests consisting of protection against potential litigation arising from concluded purchase contracts.

JEES company shall process the above-mentioned personal data of the customers for five years from the conclusion of the relevant purchase contract.

JEES company shall process the customer's personal data on its own. If the ordered goods are delivered, at the customer's request, to the address stated in the order, JEES company shall provide the suitable carrier with customer's personal data (in the extent of the name, surname, telephone number, and delivery address).

JEES company shall collect feedback and thus to process the customers' email addresses, by sending a satisfaction questionnaire regarding the production and supply implementation of the JEES company's products, under Section 7 of Act No. 480/2004 Coll., on certain Information Society Services.

JEES company shall carry out the feedback and processing of customers' email addresses on its own.

5. Processing of personal data in connection with dealing with complaints, inquiries and complaints

Customers and other persons can contact the company with their questions and requests by sending such request whether by telephone, e-mail or mail, delivered by the postal service provider.

JEES company shall process personal data provided by the person who made the query or request for purposes of answering such questions and meeting the requirements. The personal data provided in this way will only be processed by the Company in the necessary (provided) scope and only until the query or request is processed unless the need to process personal data for another purpose (for example, to protect the rights and interests of JEES company) arises. This personal data is provided to JEES company voluntarily, as, without the knowledge of the data, the company would not be able to deal with the query or request, and therefore the consent for processing is not needed.

In the event of a complaint, JEES company shall also process personal data to settle such a claim. The legal ground for the personal data processing is the fulfilment of the contractual and statutory obligations of JEES company, and therefore such processing of personal data does not require the consent of the person claiming complaint. In connection with the settling of complaints, JEES company processes personal data furthermore to protect its rights and legally protected interests, in the event of a possible dispute arising out of the complaint. The customer's consent is neither required in this case. The time, scope and other aspects of processing personal data to settle the complaint depend on the JEES company's obligation to settle the complaint.

Processing of the provided personal data will be carried out by the JEES company, without handing it over to third parties. If appropriate or necessary, JEES company is entitled to hand over the processed personal data to its suppliers and manufacturers for purposes of processing and dealing with a query, claim, or complaint. JEES company can hand over the personal data to a particular supplier or manufacturer in this way, but it depends on the product which is in the process of complaint and also on the place of purchase (JEES company may use different vendors for the same products at different locations).

6. Personal Data Processors

The Data Controller provides personal data for further processing provided by external legal service providers, shipping companies whose identity will be communicated to the data subject on request.

7. Other recipients

A Data Controller may, due to a legitimate interest, make the provided personal data available to authorised partners in a relationship, in the area of IT Services and technologies, marketing services, advisory services, certification services whose identity will be communicated to the data subject on request.

8. Other Third Parties

The Data Controller provides personal data to competent public authorities, or other entities authorised to process personal data for the purposes of state supervision, prevention, investigation, detection or prosecution of criminal offences or the execution of criminal offences, including protection against threats to public security.

9. Other purposes of data processing

The Data Controller may use the provided personal data for both business and marketing purposes.

10. The period of personal data storage:

The Data Controller stores personal data for the duration of the performance of the contractual relationship and the period required by law. An exception may be the storage of personal data for business and marketing purposes.

11. Other rights of the data subject connected with the personal data protection

When processing personal data by JEES company, there is no decision based exclusively on automated processing that would have legal effects or would otherwise significantly affect data subjects whose personal data are processed by JEES company under this Privacy Statement.

Data subjects, whose personal data are processed by the JEES company, have the following rights related to the processing of their personal data, in case of the fulfilment of the preconditions stipulated by the legal regulations:

- the right of access to personal data consisting of the right to receive information about the personal data that is processed by the JEES company, for free of charge and upon request;
- the right to rectify personal data;
- the right to have personal data erased;
- the right to restrict personal data processing;
- the right to personal data portability;
- the right to withdraw the consent to the processing of personal data at any time, if the consent is the legal ground for the processing of personal data (i.e. for sending newsletter and other advertising messages).

Data subjects, whose personal data is processed by JEES company, have the right to object to the processing of their personal data when the legal requirements are met, provided that the legal basis of the processing is justified by the interests of JEES company (i.e. processing of personal data for internal administrative purposes or protection against possible litigation).

Data subjects, whose personal data is processed by the JEES company, may make the rights mentioned above, as well as complaints in writing or by e-mail to JEES company, as a Personal Data Controller, on the contact details stated in Article 1 above.

Users and other persons, whose personal data are processed by JEES company, may also address their complaints to a data protection authority - the Office for Personal Data Protection, with registered office at Pplk. Sochova 27, 170 00 Prague 7, tel.: +420/234 665 111, www: www.uouu.cz.

12. Failure to provide personal data

The data subject must provide personal data for legitimate reasons or specified in the sales contract; otherwise, the execution of the sales contract would be impossible.

13. Other provisions:

If the data subject provides the Data Controller with consent to the handling of personal data or does not enter into a business relationship with the Controller and there are not otherwise required reasons for processing, his or her personal data in writing will be scrapped, and personal data in electronic form will be deleted.

Other personal data that the data subject has not provided personally to the Data Controller may be obtained from publicly available sources.
